This Memorandum of Understanding (hereinafter referred to as "MoU") is made at Greater Noida on

Between

IIMT College of Law having its address at Plot No. 19 & 20, Knowledge Park-III, Greater Noida, UP, India through the Director, IIMT College of Law of the one part (hereinafter referred to as IIMT College of Law)

AND

A.K.P Degree College, Khurja having its administrative office at New Shivpuri, Khurja, U.P, through the Principal, A.K.P Degree College, Khurja of the second part (hereinafter referred to as A.K.P Degree College)

WHEREAS, IIMT College of Law and A.K.P Degree College have a common objective of the training, placement and internship development and dissemination of knowledge and skills for the profession.

AND WHEREAS, in order to encourage close R & D and Co-curricular ties, IIMT College of Law and A.K.P Degree College are willing to cooperate for conducting joint activities in common areas of interest and benefit to both the organizations for research and legal purpose.

AND WHEREAS, IIMT College of Law and A.K.P Degree College desire to enter into a MoU which will serve as a general framework for cooperation between the two organizations and to facilitate discussions of specific program.

AND WHEREAS, the activities under this MoU will be carried out through the Director, IIMT College of Law and the Principal, A.K.P Degree College.

NOW, THEREFORE, in consideration of the mutual covenants contained herein IIMT College of Law and A.K.P Degree College agree as follows:



Both A.K.P Degree College and IIMT College of Law jointly agree:

1. To jointly organize seminars, conferences, or workshops etc. on the topics of mutual interest and to invite each other's members to participate therein.
2. To collaborate in Humanities and Law for collaborative research programs and will ensure their facilities and faculties accordingly.
3. IIMT College of Law and A.K.P Degree College agree student training, placement and internship program.
4. To organize training activities and development programs of mutual interest potentially beneficial and agreed by both the organizations.
5. To share research results and publish jointly in collaborative projects.
6. To exchange, on a reciprocal basis, students for limited periods of time for purpose of training, placement and internship.
7. This MoU is non-binding, non-enforceable and nor financial ramification, but rather a way of mutual understanding for increasing both organization a mutual synergic benefit.

Tenure and Termination:

This MoU will take effect from the date, it is signed by representatives of the two organizations. It will remain valid for one year, and may be continued thereafter suitable review and agreement. Either organization may terminate the MoU by giving written notice to the other organization three months in advance. Once terminated, neither IIMT College of Law Greater Noida nor A.K.P Degree College will be responsible for any losses, financial or otherwise, which the other organization suffer. However, IIMT College of Law, Greater Noida and A.K.P Degree College will ensure that all activities in progress are allowed to complete successfully.

Arbitration Clause:

In case of any dispute relating to any aspect of academic cooperation, Director, IIMT College of Law, Greater Noida and Principal, A.K.P Degree College will jointly resolve the dispute in a spirit of independent, mutual respect, and shared responsibility.
